# TAISHO KAMPO STOMACH MEDICINE <TABLETS>

- ♦ A slow stomach may develop uncomfortable symptoms such as bloating. However, excessive stomach activity and muscle tightness may cause stomach pain and abdominal pain.
- ◆ TAISHO KAMPO STOMACH MEDICINE < TABLETS> uses a combination of Anchusan and Shakuyakukanzoto to adjust the activity of your gastrointestinal tract to bring it closer to its natural state.
- ◆ It is a gastrointestinal drug suitable for people who usually have a weak gastrointestinal tract, poor gastrointestinal tract due to irregular eating habits or summer fatigue, or people who have no appetite. This medicine improves gastrointestinal symptoms such as gastric bloating/discomfort and gastritis in patients who wish to enjoy a palatable diet and patients who wish to improve their fatigued stomach.
- ◆ It is also effective for stomach pain and abdominal pain.
- ◆A small, easy-to-swallow tablet.
- ◆This medicine can be taken by anyone age 5 and older.

#### Indication

Heavy stomach feeling, feeling of discomfort in the stomach, gastritis, stomach ache, belch, loss of appetite, feeling of abdominal distention, pressure on the chest, heartburn, chlorhydria, abdominal pain, nausea (churning of stomach and vomiturition)

## **Dosage and administration**

Take the following dose with cold or lukewarm water before a meal or between meals.

Adults (15 years or over): 4 tablets per dose, 3 times daily

5 to 14 years: 2 tablets per dose, 3 times daily

Under 5 years: Do not take

# Precaution

- · Comply with the prescribed dosage and administration instructions.
- The use of the drug in children should be supervised by a parent.
- Do not return the tablets touched by wet fingers into the jar. (It will cause discoloration and may deteriorate the quality.)

# Ingredient

#### In 4 tablets

Anchusan 700mg

(equivalent to 200mg of Cinnamon Bark, 150mg of Corydalis Tuber, 150mg of Oyster Shell, 75mg of Fennel, 50mg of Amomum Seed, 50mg of Glycyrrhiza, 25mg of Alpinia officinarum Rhizome)

Shakuyakukanzoto Extract 140mg

(Peony Root 280mg, Glycyrrhiza 280mg)

Excipients

Anhydrous silicic acid, cellulose, croscarmellose sodium, magnesium stearate

The drug contains herbal medicine as a raw ingredient. The color of the drug may differ slightly, but this will not affect the efficacy.
